

**Call for NMWS-SC Artists and Entry Form
February 2024 NMWS-SC Members Only Alternate Spaces Show
“For the Love of Art,” Friday February 2 – Wednesday February 28
Frame & Art Center, 1100 S. Main Street, Las Cruces**

SC members (dues paid current) are invited to participate in an unjuried show at Frame & Art, 1100 S. Main Street in Las Cruces during the month of February, “FOR THE LOVE OF ART” month in Dona Ana County.

Here are the details:

- All works to be IMAGE SIZE 7” X 10” (traditional frame) or 8” X 10” (mounted on panel).
- Theme is “For the Love of Art” and can include any genre or subject.
- Framing--Entrants have 2 options: **1 – 7 X 10 image with mat and framed in an 11” X 14” gallery frame (simple frame) with a white or off-white mat and plexiglass, or 2 – work mounted on an 8 X 10” deep cradled panel (1½” deep).** ALL WORKS MUST BE PROFESSIONALLY PRESENTED AND READY TO HANG WITH WIRE PEAKING AT 3” BELOW TOP OF FRAME OR 3” BELOW TOP OF PANEL. NO WIDE “ROCOCCO” FRAMES, COLORED MATS OR WORK THAT IS NOT PRESENTED NEATLY. Be sure your name and contact info are on the back of the painting.
- Venue will collect 10% of the sale price on sold work, so price your work accordingly.
- Intake is 10:00-noon on Friday, January 26 – NO WORKS WILL BE ACCEPTED OUTSIDE OF THIS TIME; pickup of unsold works will be 10:00-noon on Tuesday, February 28 NO WORKS WILL BE RELEASED OUTSIDE OF THIS TIME.
- Two entries per member. Entry Fee is \$15 for one painting, \$20 for two. Complete the entry form below and email, photo and text, hand carry or mail to Exhibitions Chair Laurel Weathersbee, laurel.weathersbee@gmail.com, 575-288-5125. Checks must be made payable to NMWS-SC; **entry form and check must be received by Laurel no later than JANUARY 19! (EXTENDED DEADLINE)** Artists are invited to submit digital images to Laurel for possible use in promotion.
- An artists’ reception/opening will be held from 4:00-6:00 p.m. on Friday, February 2 at Frame & Art. Artists are expected to be present to greet the public. Visitors may attend the reception or anytime during Frame & Art’s regular shop hours, 9:00-5:30 M-F and 10:00-3:00 on Saturday. Closed Sunday.
- The show will close on Wednesday, February 28. Artists must pick up unsold works between 10:00 and Noon on Wednesday, February 28.
